PART 1 GENERAL

1.1 RELATED DOCUMENTS

A. Drawings and general provisions of the Contract, including General Conditions and Division 1 Specification Sections, apply to this Section.

1.2 SUMMARY

- A. Section Includes:
 - 1. Public-use washroom accessories.
 - 2. Underlavatory guards.
 - 3. Custodial accessories.
- B. Related Sections:
 - Division 9 Section "Ceramic Tile" for ceramic toilet and bath accessories.

1.3 QUALITY ASSURANCE

- A. The work of this section shall be performed by a company which specializes in the type of toilet and bath accessories work required for this Project, with a minimum of 5 years of documented successful experience and shall be performed by skilled workmen thoroughly experienced in the necessary crafts.
 - Work shall be performed in compliance with Owner's insurance underwriters' requirements and UL approvals and testing for materials, assemblies and procedures.
- B. Manufacturer shall specialize in manufacturing the type of toilet and bath accessories specified in this section, with a minimum of 5 years of documented successful experience, and have the facilities capable of meeting all requirements of Contract Documents as a single-source responsibility and warranty.
- C. Source Limitations: For products listed together in the same Part 2 articles, obtain products from single source from single manufacturer.
- D. Electrical Components, Devices, and Accessories: Listed and labeled as defined in NFPA 70, by a qualified testing agency, and marked for intended location and application.
- E. The "Mock-up Room" specified in Section 09 00 00 must be accepted by Architect and Owner before proceeding with toilet and related accessories work.
- F. Manufacturer's identification tags or marks are not acceptable on surfaces which will remain exposed to view after installation.
 - 1. Evidence of "patching" after removal of tags or marks is not acceptable.

1.4 SUBMITTALS

- A. Submit the following according to Conditions of the Construction Contract and Division 1 Specification Sections.
- B. Shop Drawings: Shall clearly indicate but not be limited to:
 - Locations, mounting heights and method of securing each type of toilet accessory, coordinating with tile layouts.
- C. Product Data: For each type of product indicated. Include the following:
 - 1. Construction details and dimensions.
 - 2. Anchoring and mounting requirements, including requirements for cutouts in other work and substrate preparation.
 - 3. Material and finish descriptions.
 - 4. Features that will be included for Project.
 - 5. Manufacturer's warranty.
- D. Samples: Full size, for each accessory item to verify design, operation, and finish requirements.
 - 1. Approved full-size Samples will be returned and may be used in the Work.

- E. Product Schedule: Indicating types, quantities, sizes, and installation locations by room of each accessory required.
 - 1. Identify locations using room designations indicated.
 - 2. Identify products using designations indicated.
- F. Maintenance Data: For toilet and bath accessories to include in maintenance manuals.
- G. Warranty: Sample of special warranty.
- H. Hazardous Materials Notification: In the event no product or material is available that does not contain asbestos, PCB or other hazardous materials as determined by the Owner, a "Material Safety Data Sheet" (MSDS) equivalent to OSHA Form 20 shall be submitted for that proposed product or material prior to installation.
- Asbestos and PCB Certification: After completion of installation, but prior to Substantial Completion, Contractor shall certify in writing that products and materials installed, and processes used, do not contain asbestos or polychlorinated biphenyls (PCB), using format in Article 3 of General Conditions.

1.5 DELIVERY, STORAGE, AND HANDLING

A. Comply with General Conditions and Division 1 Section "Product Requirements".

1.6 COORDINATION

- A. Coordinate accessory locations with other work to prevent interference with clearances required for access by people with disabilities, and for proper installation, adjustment, operation, cleaning, and servicing of accessories.
- B. Deliver inserts and anchoring devices set into concrete or masonry as required to prevent delaying the Work.

1.7 WARRANTY

- A. Comply with General Conditions and Division 1 Section "Product Requirements".
- B. Special Mirror Warranty: Manufacturer's standard form in which manufacturer agrees to replace mirrors that develop visible silver spoilage defects and that fail in materials or workmanship within specified warranty period.
 Warranty Period: 15 years from date of Substantial Completion.

PART 2 PRODUCTS

2.1 UNAUTHORIZED MATERIALS

A. Materials and products required for work of this section shall not contain asbestos, polychlorinated biphenyls (PCB) or other hazardous materials identified by the Owner.

2.2 ACCEPTABLE MANUFACTURERS

- A. Products of the manufacturers specified in this section establish the minimum functional, aesthetic and quality standards required for work of this section.
- B. Substitutions: Comply with General Conditions using form in Division 1 Section "Substitution Request Form".

2.3 MATERIALS

- Stainless Steel: ASTM A666, Type 304, 0.031-inch (0.8-mm) minimum nominal thickness unless otherwise indicated.
- B. Brass: ASTM B19, flat products; ASTM B16/B 16M, rods, shapes, forgings, and flat products with finished edges; or ASTM B30, castings.
- C. Steel Sheet: ASTM A1008/A 1008M, Designation CS (cold rolled, commercial steel), 0.036-inch (0.9-mm) minimum nominal thickness.
- D. Galvanized-Steel Sheet: ASTM A653/A 653M, with G60 (Z180) hot-dip zinc coating.
- E. Galvanized-Steel Mounting Devices: ASTM A153/A 153M, hot-dip galvanized after fabrication.

- F. Fasteners: Screws, bolts, and other devices of same material as accessory unit and tamper-and-theft resistant where exposed, and of galvanized steel where concealed.
- G. Chrome Plating: ASTM B456, Service Condition Number SC 2 (moderate service).
- H. Mirrors: ASTM C1503, Mirror Glazing Quality, clear-glass mirrors, nominal 6.0 mm thick.
- I. ABS Plastic: Acrylonitrile-butadiene-styrene resin formulation.

2.4 WASHROOM ACCESSORIES

- A. Manufacturers: Subject to compliance with requirements, provide products by the following:
- B. Products: As scheduled in drawings.
 - 1. Bobrick Washroom Equipment, Inc.

2.5 UNDERLAVATORY GUARDS

- A. Manufacturers: Subject to compliance with requirements, provide products by one of the following:
 - 1. Plumberex Specialty Products, Inc.
 - 2. Truebro by IPS Corporation.
- B. Underlavatory Guard:
 - Description: Insulating pipe covering for supply and drain piping assemblies that prevent direct contact with and burns from piping; allow service access without removing coverings.
 - 2. Material and Finish: Antimicrobial, molded plastic, white.

2.6 CUSTODIAL ACCESSORIES

- A. Manufacturers: Subject to compliance with requirements, provide products by the following:
 - 1. Bobrick Washroom Equipment, Inc.
- B. Mop and Broom Holder.
 - 2. Description: Unit with shelf, hooks, holders, and rod suspended beneath shelf.
 - 3. Length: 36 inches (914 mm).
 - Hooks: Three.
 - 5. Mop/Broom Holders: Four, spring-loaded, rubber hat, cam type.
 - 6. Material and Finish: Stainless steel, No. 4 finish (satin).
 - a. Shelf: Not less than nominal 0.05-inch- (1.3-mm-) thick stainless steel.
 - b. Rod: Approximately 1/4-inch- (6-mm-) diameter stainless steel.

2.7 FABRICATION

- A. General: Fabricate units with tight seams and joints, and exposed edges rolled.
 - 1. Hang doors and access panels with full-length, continuous hinges.
 - 2. Equip units for concealed anchorage and with corrosion-resistant backing plates.
- B. Names or labels are not permitted on exposed faces of accessories.
 - On interior surface not exposed to view or on back surface of each accessory, provide printed, waterproof label or stamped nameplate indicating manufacturer's name and product model number.
- C. Keys: Provide universal keys for internal access to accessories for servicing and resupplying. Provide minimum of six keys to Owner's representative.

PART 3 EXECUTION

3.1 INSTALLATION

A. Install accessories according to manufacturers' written instructions, using fasteners appropriate to substrate indicated and recommended by unit manufacturer. Install units level, plumb, and firmly anchored in locations and at heights indicated.

- B. Grab Bars: Install to withstand a downward load of at least 250 lbf (1112 N), when tested according to ASTM F446.
- Unless otherwise indicated, locations of accessories shall conform to tile coursing and heights from finished floor as shown on drawings.
 - 1. Where locations are not indicated, locations of accessories shall be as indicated by Architect.
 - Care shall be exercised at all times to assure that tile surfaces are not cracked, chipped or damaged, and that finishes of toilet partitions are not abraded, scratched or damaged.
- D. Installed accessories shall operate quietly and smoothly.
 - 1. Doors and operating hardware shall function without binding or unnecessary friction.
 - 2. Coin boxes for dispenser type accessories shall be keyed alike and different from the other keyed accessories.
 - 3. Keys shall be turned over to Owner's authorized agent, obtaining receipt for such delivery.
- E. Install sealant between fixtures and adjacent tile or other wall finishes to achieve a tight, closed finished appearance at recessed accessories.
 - 1. Sealant shall conform to requirements of Division 7 Section "Joint Sealants".
- F. Mirrors:
 - 1. Coordinate toilet accessories with mirror installation.

3.2 ADJUSTING AND CLEANING

- A. Adjust accessories for unencumbered, smooth operation. Replace damaged or defective items.
- B. Remove temporary labels and protective coatings.
- C. Clean and polish exposed surfaces according to manufacturer's written recommendations.
