Specific Scope Requirements:

The Subcontractor's Work is to include, but not be limited to providing all labor, supervision, installation, layout, engineering, hoisting, unloading, parking, shop drawings, submittals, mockups, benchmarks, fabrication, materials, equipment, services, supplies, tools, facilities, transportation, storage, protection, handling, licenses, inspections, taxes (federal, state, county, local, etc.), overhead, profit, insurance, etc. as required to timely complete the Interior Glass in accordance with the Agreement and as more specifically defined in the Specification Sections listed below and as clarified thereafter. Enumeration of the Specification Sections herein is for the convenience of DPR and the Subcontractor and does not limit Subcontractor's responsibility to provide all of the Interior Glass required by the Contract Documents and as clarified below.

3. GENERAL CLARIFICATIONS

- a. The Glazing (Interiors Only) scope includes but is not limited to:
 - i. All glass doors and related door hardware.
 - ii. Glazing with U-channels top and bottom.
 - iii. 3M Film.
 - iv. Glazing of door lites & window frames.
 - v. Glass marker boards.
 - vi. Shower Doors
- b. Cleaning of glass for post-installation inspections is included.

4. SCOPE ITEM NO. 1 – ALL GLASS DOORS AND DOOR HARDWARE

- a. Include all Type D or DD doors and associated door hardware.
- b. Include all Type E or E1 doors and associated door hardware.

5. SCOPE ITEM NO. 2 – GLAZING WITH U-CHANNEL TOP AND BOTTOM

- a. Include all glass wall systems.
- b. Include glass transoms and door side-lites at all glass doors.

- c. Include full height glass wall and all glass door at Conference Room 105.
- d. All windows that receive wood wrapped frame (i.e. detail 1/A-312-TI) assumed to be frameless glass mounted in u-channel. Wood wrap by others.

6. SCOPE ITEM NO. 3 – GLASS FILM @ OFFICE STOREFRONTS

- a. Include all glass film per Keynote 06 on Construction Plans.
- b. Coverage to be 50% of window.
- c. Reference finish schedule A-120-TI for film specifications.

7. SCOPE ITEM NO. 4 – GLAZING OF DOOR LITES & OFFICE STOREFRONTS

- a. Include glazing of door lites and office fronts in frames provided by others.
- b. Include removal and re-installation of glass stops.
- c. Include for both aluminum and hollow metal frames.

8. SCOPE ITEM NO. 5 – GLASS MARKER BOARDS

- a. Include all glass marker boards as indicated in the design documents.
- b. Reference detail 26/A-613-TI.
- c. Include all associated hardware and aluminum tray.

9. SCOPE ITEM NO. 6 – SHOWER DOORS

- a. Include all shower room doors including 141A, 141B, 143A, 143B
- b. Reference details sheet A-401-TI

10. EXCLUSIONS

- a. All exterior glazing.
- b. Concrete demolition or patching to accommodate floor closers.
- c. Prevailing wages
- d. Debris boxes
- e. Bonds
- f. Glass deli doors at cold rooms.
- g. 3Form panels at umbilicals.
- h. Won doors 201A and 201B.
- i. Wood wrapping at interior windows.
- j. Glass tile at break rooms.
