

1.1 INTRODUCTION AND GENERAL INFORMATION

This Request for Proposal (RFP) seeks objectives from Offerors to construct, and perform other identified activities for the Deweyville Trailhead to Neck Lake Road project (the "Project") on Prince of Wales Island, Alaska.

For the purpose of the ASC Reno Competition Kiewit has managed the design for FHWA and put together a bid package for teams to bid on. No design alterations are accepted from the RFC design included in the bid package.

1.2 **DEFINITIONS**

- "CO" means the contracting officer for FHWA.
- "Design-Build Team" means the individual(s) or entity(ies) responsible for the construction elements presented in the offer. The team may consist of one or more individuals or entities who have the overall responsibility for the construction of the Project.
- "Federal Acquisition Regulation (FAR)" means the regulation setting forth the policies and procedures governing this procurement.
- "FHWA" means the Federal Highway Administration, which is the procuring agency.
- "Offeror" means a Design-Build Team submitting a Statement of Qualifications (SOQ) for the Project in response to this RFQ, or submitting a Proposal in response to the Request for Proposals (RFP).
- "Project" means the Deweyville Trailhead to Neck Lake Road project (the "Project") on Prince of Wales Island, Alaska that is the subject of this procurement action.
- "Proposal" means the proposal(s) submitted by the short-listed Design-Build Teams in response to the Request for Proposals (RFP) including all revisions.
- "Request for Proposals (RFP)" means a document used to solicit proposals from Design-Build Teams to design and construct a highway project. The RFP is issued only to Design-Build Teams who are on the Short-List.
- "Request for Qualifications (RFQ)" means a document issued by FHWA as the first step of a two-step selection process that requests interested Design-Build teams to submit an SOQ. The RFQ describes the project in enough detail to let potential Design-Build Teams determine if they wish to submit an SOQ. The RFQ forms the basis for developing a Short-List of the most qualified Design-Build Teams.
- "Short-List" means the list of those Offerors, having submitted SOQs, that FHWA determines are the most highly qualified Design-Build Teams and will be invited to submit Proposals in response to an RFP.
- "Statement of Qualifications (SOQ)" means the information prepared and submitted by an Offeror in response to this RFQ.

1.3 PROJECT GOALS

FHWA's goals for the project are:

- Do not impact the current project under construction between MP 68.8 and MP 81.0.
- Complete construction of the project within the programmed budget.
- Select a Design-Build Team whose quality management practices ensure the requirements of the project will be met or exceeded, without the need for rework, and with minimal direction from FHWA.
- Minimize the overall construction duration.
- Minimize the overall project duration.

1.4 PROJECT DESCRIPTION

1.3.1 General Description

The estimated cost of the Project is \$25 million to \$50 million.

The Project is located within the Tongass National Forest, on Prince of Wales Island in Southeast Alaska. The Project is located along the North Prince of Wales Road (Forest Highway 43, National Forest System Road 20). The south end of the project is approximately 12 miles north of the intersection of North Prince of Wales Road and Coffman Cove Road (NFSR 23), and approximately 45 miles north of Klawock, Alaska.

The Project is located in an area of Southeast Alaska with high precipitation and with complex features such as muskeg and potentially karst. Wetlands are located along the project corridor.


Generally, the Project will consist of the following:

- Reconstruction of approximately 12 miles of North Prince of Wales Road between Deweyville Trailhead and Neck Lake Road to a two-lane roadway with an asphaltic concrete paved surface;
- Construction of bridges at Tunga Creek and Chum Creek;
- Construction of aquatic organism passages;
- Removal of the existing bridge at Chum Creek;
- Obliteration of the existing roadway; and
- Purchasing mitigation credits.

No utility work is required.

No right-of-way acquisition will be required.

1.3.2 Construction Requirements

Environmental Requirements. The National Environmental Policy Act (NEPA) decision has been made. The design and construction shall conform to the requirements established in the U.S. Forest Service's Environmental Assessment (EA), Decision Notice and Finding of No Significant Impact (FONSI), and FHWA's Categorical Exclusion (CE), as well as to all other applicable regulatory requirements. No permits (environmental or otherwise) have been obtained for the Project. The Design-Build Team will not be required to acquire necessary permits.

Construction. The Project must be constructed within the boundaries defined in, and in compliance with the FONSI and CE. The Project must be constructed so as to maintain traffic throughout the construction process. The Standard Specifications for Construction of Roads and Bridges on Federal Highway Projects (FP) and current Western Federal Lands Highway Division (WFLHD) Library of Supplemental Specifications will apply.

1.3.3 Design-Build Team Responsibilities

The Design-Build Team will be responsible for furnishing all labor, material, equipment, services, and support facilities for the Project including, but not limited to, the following:

- Construction of all project components;
- Management of the Project Construction;
- Project-related public involvement activities;
- Quality assurance/quality control of design and construction as defined in the RFP;
- Maintenance and protection of traffic, including Emergency Medical Service providers;
- Project safety and security;
- Information as necessary to successfully complete the Project design and construction;
- Drainage, erosion control, and best management practices (BMP)s;
- Construction waste disposal and handling;
- Clearances, licenses, and permits for Design-Build Team work, work sites, storage areas, etc., both on and off site;
- Ancillary work, such as temporary fencing, relocation of drainage, work sites, and temporary works;
- Material location, acquisition, permits, and transportation;
- Maintenance of the Project, except winter maintenance activities (snow removal);
- Administration of the Project during the Contract period; and

1.3.4 Project Status and Documents Provided in the RFP

Survey: FHWA has not verified the topographic survey prepared by others. Do not rely on the stakes or alignment.

Environmental: The National Environmental Policy Act (NEPA) decision has been made. Wetland delineation has been performed and this information is available in the historical data on the website. This delineation will be sufficient for permit requirements.

1.4 PROJECT SCHEDULE

The anticipated time of contract award is August 2012.

The anticipated substantial completion date is September 2015.

1.5 CONTRACT TYPE

The Contract will be a Unit price job.

1.6 INELIGIBLE FIRMS

No firms have been determined ineligible.

1.7 PRE-SOQ INFORMATIONAL MEETINGS

A Pre-SOQ informational meeting will not be held.

1.8 PRE-RFP INFORMATIONAL MEETINGS

A Pre-RFP informational meeting will not be held.

1.9 OFFEROR QUESTIONS

FHWA will consider questions submitted in writing by Offerors regarding the RFQ, including requests for clarification and requests to correct errors. All such requests must be submitted in writing via typed letter delivered to room _____.

No oral requests will be considered. No requests for additional information or clarification to any other government office, consultant, employee or agency will be considered.

A response to the question(s) will be issued to all teams.

1.10 RFP AMENDMENTS

1.11 COSTS

Offerors are solely responsible for all costs and expenses of any nature associated with responding to this RFQ and providing supplemental information.

1.12 PROPOSAL STIPEND

FHWA will provide a Stipend in the amount of \$50,000 to be paid to unsuccessful Design-Build Teams who submit complete Proposals in response to an RFP. The purpose of the Stipend is to encourage competition.

2.1 PROCUREMENT PROCESS

4.4 CONTENT OF PRESENTATION (Objectives, Submittal Requirements, and Criteria for Evaluation)

4.4.1 Understanding and Approach

A) Objective:

- 1) To identify those Offerors demonstrating an understanding of and approach to the management, technical aspects, issues and risks associated with the Project; and
- 2) To identify those Offerors who understand how to implement the construction process to meet FHWA's project goals.
- 3) Outline key community relations issues and how they will be addressed.
- 4) Explain your construction schedule on a summary level to explain how you will complete the work in a timely manner.

4.4.2 Direct Operations

A) Objective:

- 1) To identify Offerors who have demonstrated a logical plan to building the work, while providing a quality product. Should identify several key operations and discuss the Offerors approach to completing the task.
- 2) To identify Offerors whose Quality Management program is essentially independent of construction management staff and has the authority to require changes to be made to bring the work into conformance.

4.4.3 Indirect Operations

A) Objective:

- 1) To identify Offerors that will effectively manage all aspects of the Contract in a quality, timely, and effective manner.
- 2) To identify the best personnel for key management positions with demonstrated experience and expertise in and a record of producing quality work on projects of a similar size and type [i.e., two-lane (minimum) highway construction according to State or Federal standard in areas, with the following attributes: annual precipitation greater than 60 inches, muskeg, karst, large quantities of unsuitable material, wetlands, requiring compliance with State and Federal environmental requirements, and award amounts of \$5 million or more].

5.1 BID PACKAGE EVALUATION FACTORS

The Bid Package submitted by short-listed firms will be evaluated based on the following factors:

- Completed Bid Form
- Completed Bid Schedule with a Total bid amount
- Project Schedule
- Estimate binder (Organized binder which includes; back up, Takeoff's, and pricing)

The Bid Packages will be reviewed and scored based on an available 400 points.
