 - placement of at least 10 mils thick vapor retarder.
 - concrete shall be placed diirectly on the vapor retarder
 - concrete must have water/cement ratio of .45 or below, and be placed according to ACI 318 and UBC Standards
 - calcium chloride testing per ASTM F1869 is required 2 weeks prior to floor covering installation (needed to validate warranty)
