The undersigned, as bidder, declares that the only persons or parties interested in this proposal as principals are those named herein; that this proposal is made without collusion with any other person, firm or corporation; that he has carefully examined the location of the proposed work, the annexed proposed form of contract and the plans therein referred to; and he proposes and agrees if this proposal is accepted, that he will contract with the Kern-Tulare Water District, in the prescribed form of contract hereto annexed, to provide all necessary machinery, tools, apparatus and other means of construction and to do all the work and furnish all the materials in accordance with the plans and specifications for the above, filed in the office of the Kern-Tulare Water District and as specified in the contract, in the manner and time therein prescribed, and according to the requirements of the Engineer as therein set forth, and that he will take in full payment therefor the unit prices or lump sums set forth in the following schedule.

If this proposal is accepted and the undersigned fails to execute the aforesaid contract and to provide surety bonds and evidence of insurance acceptable to the District as is required within ten (10) days, not including Sundays, after the bidder receives notice from the District that the District offers to award the contract to the successful bidder, the District may, at its option, determine that the bidder has abandoned the bid proposal and the bidder's proposal guaranty shall be forfeited and shall become the property of the District. District shall then be free to accept the bid of another bidder.


