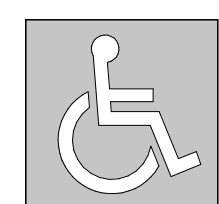

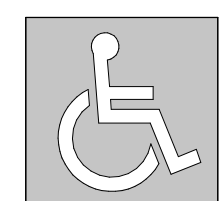

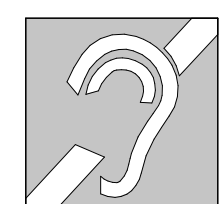


ADA MOBILITY UNIT WITH ROLL-IN SHOWER

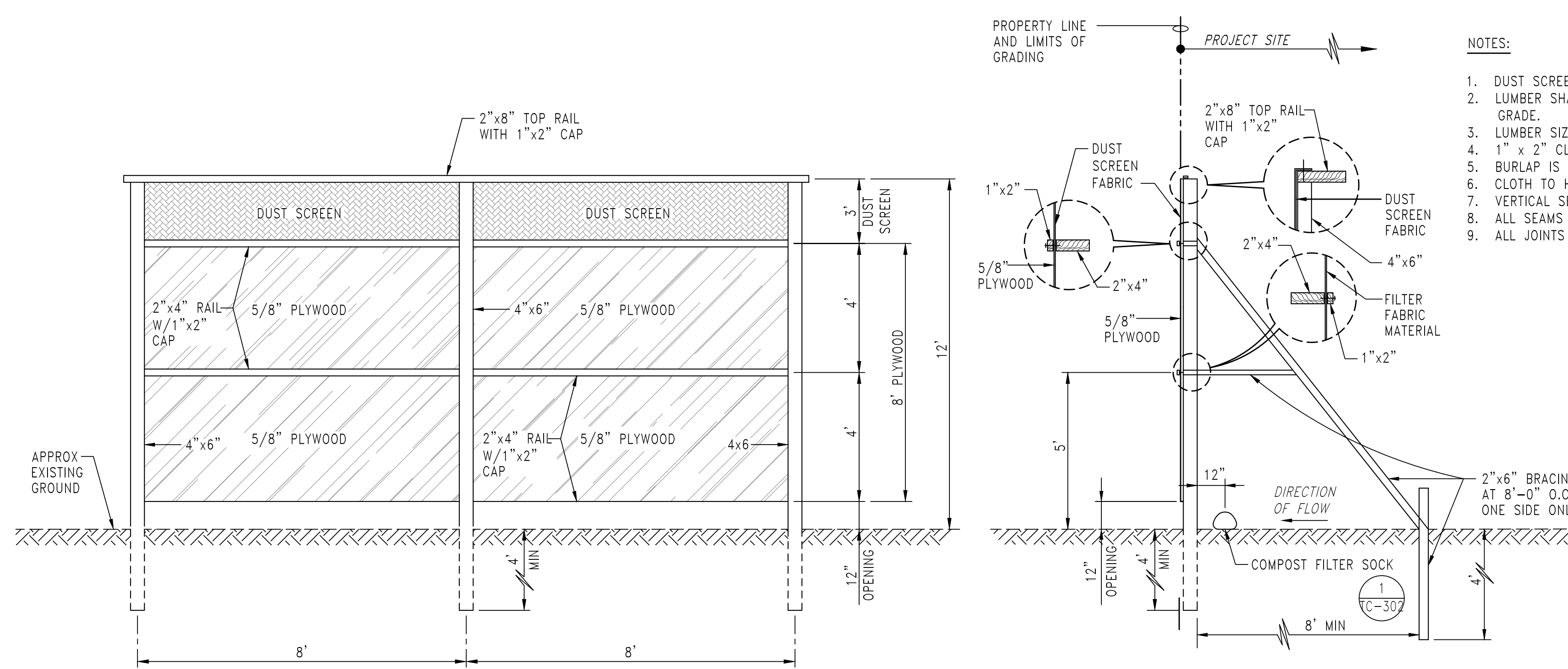

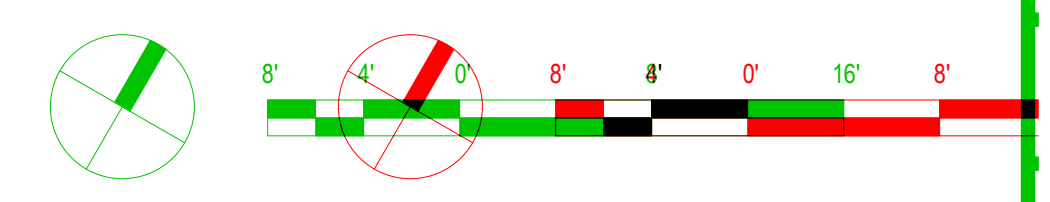
